PRODUCT INFORMATION: UltraMate SG is a sulfonated potassium humate granule, which is soluble over a wide pH range of 2.0 to 12.0. UltraMate SG completely dissolves when added directly to liquid fertilizer, micronutrient or pesticide formulations over a wide range of pH values. It allows the user to apply this humate directly into tank mix, drip irrigation and onto acid soil applications unacceptable for conventional products. UltraMate SG provides a concentrated granule that provides flexibility of dry or liquid application, and avoids unnecessary cost of shipping water as compared to liquid humate products. UltraMate SG also allows the user to avoid handling powder and dusty material and the related issues.

DIRECTIONS FOR USE: UltraMate SG can be applied to all crops including fruits, vegetables, trees, vines, flowers, ornamentals, turf, (include lawns, sod farms, commercial properties, athletic fields, golf greens, tees and fairways) grain and other row crops, greenhouse plants and other indoor crops. Application rates and frequency are dependent upon soil and climate conditions present. Typical application rates range from ½ to 3 pounds of UltraMate SG per acre per application (up to 11 pounds per growing season).

UltraMate SG may be applied as a granule, alone as a liquid or with liquid fertilizers. Also, it may be applied through conventional methods but not limited to foliar spray, soil application, drip irrigation, water run or hydroponically. UltraMate SG is not compatible with glyphosate concentrate, but will work with the tank mixes containing glyphosate.

UltraMate SG is best mixed under continuous, mild agitation or circulation and must be added to spray tanks slowly (poured not dumped). When the solution is thoroughly mixed beyond disappearance of granules, it is always good practice to probe the bottom of the vessel for any un-dissolved granules prior to application. When tank mixing with other ingredients, always start with water, UltraMate SG, followed by (in order) fertilizer, herbicide, fungicide, insecticides.

Compatibility can be simply checked by:

- Mixing each product in a clear container in the same proportion to be used in the field
- Agitating for at least 60 seconds
- Visually observing for precipitate
