Directions For Use

Rates: Mix 4 fl oz (118 ml) of Foam Concentrate per 5 gallons (18.9 L) of water as follows:

- 1. Fill foam tank approximately half full with water.
- 2. Add Foam Concentrate
- 3. Fill balance of foam tank to proper level
- 4. Premature foaming during the filling procedure may be reduced by utilizing a "bottom-filling-tube" which adds the **Foam Concentrate** to the bottom of the foam tank rather than the top

If foam appears runny and thin:

- 1. Check hose connections for proper air mixing.
- 2. Check foam rate mixed and foam equipment.

Use BASF's Foam Dye Red or Blue to enhance visibility.

NOTE: Freezing of the concentrate should not alter the marking characteristics of the foam. Allow complete thawing out of the product and shake well before using.

Storage and Disposal

Storage: Segregate from foods and animal feeds. Keep away from heat. Protect from direct sunlight.

Waste Disposal of Substance: Must be disposed of or incinerated in accordance with local regulations.

Container Disposal: Contaminated packaging should be emptied as far as possible and disposed of in the same manner as the substance/product.

Accidental Release Measures: Do not discharge into the subsoil/soil. Do not discharge into drains/ surface waters/groundwater. For small amounts: Pick up with suitable absorbent material (e.g. sand, sawdust, general-purpose binder, kieselguhr). For large amounts: Dike spillage, Pump off product.
