4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Isolate area and keep unnecessary and unprotected personnel from entering. Wear suitable personal protective clothing and equipment as described in Section 8 of this document.

Environmental Precautions: Prevent material from entering any waterways or low areas. Do not flush to drain or soil. Contain contaminated water. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. Spill Cleanup: Clean up spill immediately, observing precautions in Section 8. Control the spill at its source. Azoxystrobin can be persistent for several months or longer. Azoxystrobin and a degradate of azoxystrobin are known to leach through soil into groundwater under certain conditions as a result of label use. This product may impact surface water quality due to runoff of rain water.

This product may adversely impact the forage and habitat of local pollinators, including the monarch butterfly (and its larvae), birds, or bats if reaches non-target areas. Protect pollinators by following label directions to minimize spray drift.
