Water treated with BRANDT BLUE LAGOON is a brilliant, natural color that does not appear to be artificial. Safe with fish, waterfowl and livestock, treated water may be used for irrigation, swimming and other recreational sports.

BRANDT BLUE LAGOON is a bird blocker formulation designed to darken water sufficiently to protect against fish "poaching" in aquacultural environments.

The use of BRANDT BLUE LAGOON is simple and economical. Used as directed, BRANDT BLUE LAGOON is safe for use in irrigation ponds, without discoloring crops, turf, concrete, or other surfaces. BRANDT BLUE LAGOON will not disrupt fishing, swimming or irrigation once product has dispersed. However, do not swim, fish or irrigate from ponds treated with BRANDT BLUE LAGOON until the product has thoroughly dispersed.

BRANDT BLUE LAGOON should be applied at the rate of 1 gallon per 1 surface acre of water 4 to 6 feet deep. Add BRANDT BLUE LAGOON to ponds from several different locations to insure even dispersion. Wear rubber gloves when applying BRANDT BLUE LAGOON to protect hands from staining.
