**DIRECTIONS FOR USE**

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

**General Precautions and Restrictions**

Do not apply this product in a way that will contact adults, children, or pets, either directly or through drift. Do not apply when food is present. Exposed food should be covered or removed. All food preparation surfaces and utensils should be covered during treatment or thoroughly washed before use. Do not use in greenhouses where plants are grown for food. Wait four (4) hours after application, then open windows, vents, and doors to outdoors for one hour. There should be no remaining trace of pesticide fog or aerosol. If an odor is still detected, continue ventilating until no remaining trace or odor of pesticide remains. Do not use in aircraft cabins. When used in dairy barns or facilities: Close milk bulk tank lids to prevent contamination from spray and from dead or falling insects. Remove or cover milking utensils before application. Wash teats of animals before milking. Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application. Not for use in outdoor residential misting systems.

Do not use in food/feed areas of food/feed handling establishments, restaurants or other areas where food/feed is commercially prepared or processed. Can be used in non-food areas such as garbage rooms, lavatories, entries and vestibules, offices, boiler rooms, garages, mop closets and storage (after canning or bottling). Repeat spraying in two weeks when necessary. **Does not control bed bugs.**

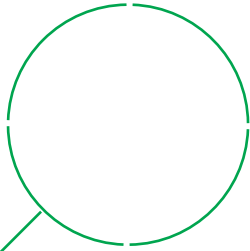
