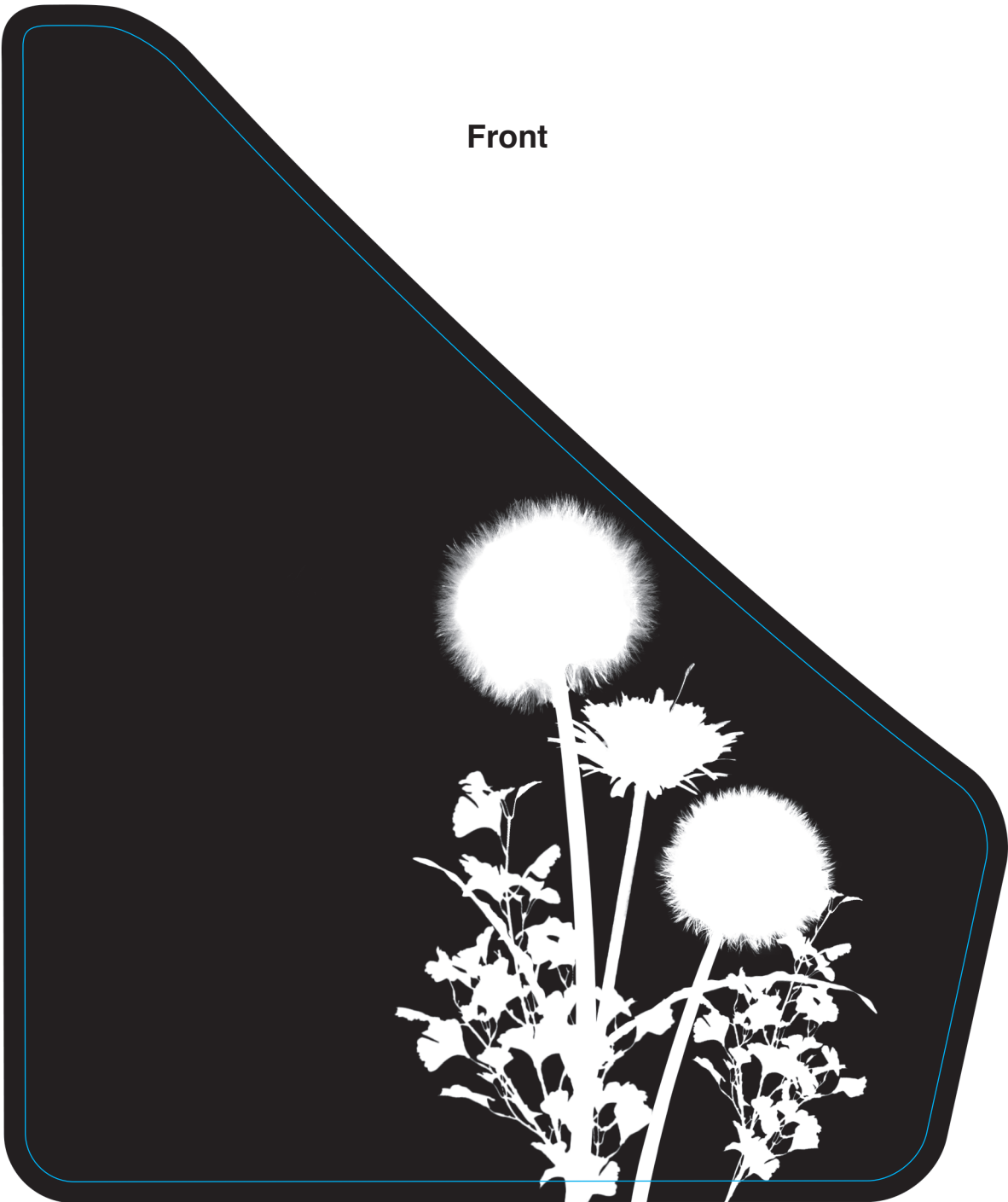


#### BEFORE YOU USE

- Ready-to-use. Do not dilute.
- Remove sprayer from holder and pull tubing out of sprayer handle. The tubing connector fits in the hole on top of the cap.
- While staining is unlikely, it is recommended to spray product on an inconspicuous area of surfaces that are intended to be treated. A test duration of 48 hours or more is recommended.
- Avoid spraying desirable plants. When spot treating around desirable plants, shield plants from drift with a sheet of cardboard or plastic. If desirable plants are accidentally sprayed, rinse off with water immediately.

#### HOW TO USE – Shake Well Before Using

**Kills:** Dandelion, Velvet Leaf, Water Hemp, Foxtail.

#### SPRAYING DIRECTIONS

- Turn nozzle to ON "Spray"  or ON "Stream"  position, before using.
- Hold container upright while spraying.
- Spray until thoroughly wet.
- Ensure thorough even coverage of the weeds and grass sprayed.

#### WHEN TO APPLY:

- Apply when weeds or grass are actively growing.
- Works best when applied to young, actively growing weeds.
- For best results apply during warm, sunny weather (above 60° F). Cloudy, cooler weather may delay or reduce efficacy.
- Spray when the air is calm to prevent drift onto desirable plants.
- If it rains within 4 hours of spraying, re-treatment may be necessary.
- Repeat as listed weeds and grass are seen.
- Treated areas may be replanted in 48 hours.
