### FIRST AID

**IF SWALLOWED:** Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

**IF ON SKIN OR CLOTHING:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a poison control center or doctor for treatment advice.

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice. Have the product container or label with you when calling a poison control center or doctor, or going for treatment. For emergency medical treatment information, you may contact SafetyCall at 1-844-685-9173, 24 hours a day, 7 days a week.

### DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling. Do not open until ready to use. Dust may form on collar during storage. Do not get dust in mouth or eyes. Only one collar is to be worn by your dog at any one time.

Remove the collar from its packaging, separate the Peel-Away Comfort Strip and place in the trash. Place collar around dog's neck and buckle in place with the main clasp. Feed excess collar through the remaining two clasps for extra hold and a clean fit. Adjust the collar for a snug fit to create contact between the collar and the dog's hair/coat for better product release and diffusion. A properly fitted collar will allow two fingers to be placed between the collar and dog's neck. The elasticity of the collar is designed to stretch in the event that the dog becomes entangled. Leave an excess of 1- 2 notches (1/4 to 3/8 inch) past the last clasp. Adjust periodically for growing dogs. Cut off and dispose of excess length. Wash hands after placing collar on dog. Replace collar every 6 six months.

#### **STORAGE AND DISPOSAL**

Do not contaminate water, food or feed by storage and disposal. Pesticide Storage: Store this product in a cool, dry place away from children and pets. Pesticide Disposal and Container Handling: Do not reuse container or used collar. Dispose of in trash.

**FLEE Flea & Tick Collar.** This collar kills fleas and ticks for up to 6 months. Collar is a double layer sustained-release system containing deltamethrin combining the insecticidal actions of vapors and powders working in three ways to provide head to tail protection. Thus, the collar has the effect of simultaneous usage of a spray and powder in the control of fleas and ticks, including ticks that may carry Rocky Mountain spotted fever. Use FLEE Flea & Tick Collar year-round for most effective control. Replace every 6 months.
