- Performs like an oil-based aerosol without staining
- Controls bed bugs, fleas and a variety of other nuisance pests



CB-80™ Insecticide: Crack and Crevice Control

- The industry's premium flushing and contact aerosol
- Features an 8:1 synergist to pyrethrins ratio
- Approved for use in food-handling establishments
- Labeled for indoor flea and bed bug control, including mattress applications



D-Foam® Insecticide: Wood Destroying Insect Control and More

- Controls pests in wall voids, floor joists and damaged wood structures
- Formulated with deltamethrin for up to eight weeks of residual protection
- Features a 60:1 expansion ratio, delivering over 10 gallons of foam from a single 20 oz can
- Also controls over 20 common pests, including ants, crickets, cockroaches and silverfish



D-Force® Insecticide: Long-Lasting Control at Low Use Rates

- The first product to feature deltamethrin in a residual aerosol
- Delivers up to eight weeks of control for over 50 labeled pests
- Can be applied directly to mattresses for bed bug control
- Effective at very low (0.06%) application rates

- Contains propoxur, a carbamate insecticide
- Delivers fast knockdown and up to six weeks of residual protection
- Controls cockroaches, spiders,* ants** and several species of beetles

Residual Fogger

Formulated with esfenvalerate to deliver economic cleanout control with 30 days of residual protection to both food and non-food areas.
