4. FIRST AID MEASURES:

If in Eyes: Hold eye open and rinse slowly and gently with water for 15 to 20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control center or doctor for treatment advice.

6. ACCIDENTIAL RELEASE MEASURES:

7. HANDLING AND STORAGE:

Subchronic (Target Organ) Effects: Repeated overexposure to halosulfuron-methyl may cause effects to kidneys, liver, blood and decreased body organ weights.

Carcinogenicity / Chronic Health Effects: Repeated overexposure to halosulfuron-methyl may cause effects to kidneys, liver, and blood. No carcinogenic effects were observed in animal tests with halosulfuron-methyl.

Reproductive Toxicity: Animal tests with halosulfuron-methyl have not demonstrated reproductive effects.

Developmental Toxicity: At doses that were toxic to mother animals, studies on halosulfuron-methyl resulted in increased resorptions, decreases pup weights and malformations.

Genotoxicity: Halosulfuron-methyl did not product genetic changes in a variety of standard tests using animals and animal or bacterial cells.

Assessment Carcinogenicity: None listed with ACGIH, IARC, NTP, or OSHA.

Environmental Fate:

Halosulfuron-methyl is degraded by microbes and by non-microbial hydrolysis with rapid rates at both high and low pH soils. Under anaerobic conditions, however; microbial degradation is slow and most degradation is by hydrolysis. Terrestrial and aquatic half-life ranged from 13-27 days.

13. DISPOSAL CONSIDERATIONS:

Waste Disposal Method:

Pesticides wastes are acutely hazardous. Improper disposal of excess pesticide, spray mixture or rinsate is a violation of Federal law. Container Handling and Disposal:

Plastic Bottle Packaging: Nonrefillable container. Do not reuse or refill this container. Triple rinse or pressure rinse container (or equivalent) promptly after emptying. Triple rinse as follows: Empty the remaining contents into application equipment or a mix tank and drain for 10 seconds after the flow begins to drip. Fill the container ¼ full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank. Drain for 10 seconds after the flow beings to drip. Repeat this procedure two more times. Pressure rinse as follows: Empty the remaining contents into application equipment or a mix tank and continue to drain for 10 seconds after the flow begins to drip. Hold container upside down over application equipment or mix tank or collect rinsate for later use or disposal. Insert pressure rinsing nozzle in the side of the container, and rinse at about 40 psi for at least 30 seconds. Drain for 10 seconds after the flow beings to drip.

Once triple rinsed, recycle if available. Some agricultural pesticide containers can be taken to a container collection site or pick up for recycling. To find the nearest site, contact your chemical dealer or manufacturer. If recycling is not available, dispose of in a sanitary landfill or by incineration if allowed by state and local ordinances.

Water Soluble Packaging: Nonrefillable contain. Do not reuse or refill this container. Completely water soluble bags into application equipment. Then offer for recycling if available, or dispose of empty foil pouch and cardbox in a sanitary landfill, or by incineration, or by burning, if allowed by state and local authorities.
