### 4. FIRST AID MEASURES

#### 4.1. Description of first aid measures

##### General advice

Abamectin may cause dilation of pupils, muscular incoordination, and muscular tremors with ingestion of more than an incidental amount.

#### 4.3. Indication of any immediate medical attention and special treatment needed, if necessary

Toxicity following accidental ingestion of more than an incidental amount can be minimized by early administration of chemical adsorbents (e.g. activated charcoal).
