**Conditions for safe storage, including any incompatibilities**

- : Store in accordance with local regulations. 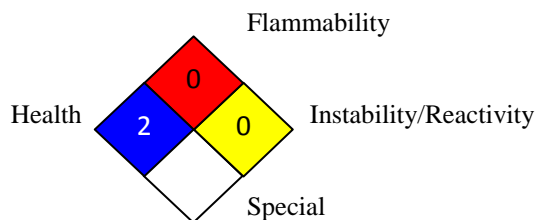
