## **KEEP OUT OF REACH OF CHILDREN CAUTION FIRST AID**

**IF IN EYES:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a Poison Control Center or doctor for treatment advice.

**IF ON SKIN:** Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call a Poison Control Center or doctor for treatment advice. If a physician or Poison Control Center.

**IF SWALLOWED:** Call a Poison Control Center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to by a Poison Control Center or doctor. Do not give anything by mouth to an unconscious person.

**CAUTION:** Causes moderate eye irritation. Harmful if swallowed, inhaled, or absorbed through skin. Avoid contact with skin, eyes, or clothing. Avoid breathing spray mist. Wear long sleeved shirt, long pants, shoes plus socks and chemical resistant gloves made of any waterproof material when mixing or handling concentrate. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, or using tobacco. Remove and wash contaminated clothing before reuse.

## **DIRECTIONS FOR USE**

NO FOAM A is used to give optimum wetting and spreading of plant protection products such as insecticides, miticides, fungicides and herbicides.

NO FOAM A is formulated from materials which do not tend to burn foliage or leave harmful residues. There will be no excessive foaming when high pressures are used. Use of correct quantity for smooth wetting reduces the possibility of spot injury from large pesticide droplets.

Proper quantity to use will vary with the type of equipment, spray volume, temperature, type of foliage to wet, and the pesticide formulation. Also, higher rates than those below may be used if recommended by pesticide labeling. Follow pesticide label directions. However, do not add this product at a rate which exceeds 5% of the finished spray volume.

**Dilute Sprays:** Use 1/8 - 1/2 tsp. per gallon of water.
