## **ENVIRONMENTAL HAZARDS**

This pesticide is extremely toxic to fish. Do not apply directly to water. Avoid contamination of ornamental fish ponds. #### **USE RESTRICTIONS**

- Not for use on plants being grown for sale or other commercial seed production, or for research purposes.
- Do not allow adults, children, or pets to enter the treated area until sprays have dried.
- Application is prohibited directly into sewers or drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application.

- All outdoor applications must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:
  - Treatment to soil or vegetation around structures;
  - Applications to lawns, turf, and other vegetation;
  - Applications to building foundations, up to a maximum height of 3 feet.

### HOW TO APPLY

#### PESTS ON DOG PREMISES (Dog Houses, Runs and Yards)

Fleas, Flies, Ticks, Lice and Mange	Dilute 4 fl. ozs. in 1 gal. water	Thoroughly spray infested areas, pet beds and resting quarters. Fresh bedding should be placed in animal quarters following treatment. Do not spray feed, food or water. Repeat as needed but not more than once every two weeks.

#### PESTS ON DOGS (DO NOT TREAT PUPPIES LESS THAN TWELVE [12] WEEKS OF AGE)

Fleas, Ticks, including Deer Ticks (carriers of Lyme disease), Lice and Mange	Dilute 2 fl. ozs. in 1 gal. water	Thoroughly wet the animal by dipping, sponging or spraying. Allow animal to dry in a warm place without rinsing or toweling. Do not reapply product for two to three weeks. Consult a veterinarian before using this product on debilitated, aged, pregnant or nursing animals or animals on medication.
	Dilute 1 pt. in 8 gals. water	<b>Sensitivities may occur after using ANY pesticide product for pets. If signs of sensitivity occur, bathe your pet with mild soap and rinse with large amounts of water. If signs continue, consult a veterinarian immediately.</b>

## STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage or disposal.

**Storage and Spill Procedures:** Store upright at room temperature. Avoid exposure to extreme temperatures. Store in a locked area out of reach of children and domestic animals.
