## General Information

N-BORON is designed for application to field, row, vegetable, fruit, tree, vine and ornamental crops for the prevention and correction of boron deficiency when used as part of a balanced fertility program.

## Rate Recommendations

### Field, Row, Vegetable, Fruit, Tree and Vine Crops:

Apply 1-4 pints per acre per application throughout the growing season. At least 2 applications are recommended. More frequent applications of 1.5 quarts per acre may be needed to correct deficiencies once they occur.

**Ornamental Crops:** Apply 1-4 pints per 100 gallons water. Cover foliage thoroughly to point of runoff.

Optimum rate of application will vary depending on soil properties (such as pH, organic matter content, texture), weather conditions, time of year, general crop health and crop species. For best results, follow soil test or plant analysis recommendation.

**WARNING:** N-BORON is recommended for all crops where boron may be deficient; however overapplication may result in serious injury to susceptible crops.

## Mixing and Handling Instructions

Apply in a minimum of 10 gallons water per acre for ground spray equipment or 2 gallons water per acre for aerial application. N-BORON may also be applied via drip or sprinkler fertigation.

Put 1/3 to 2/3 of total required water volume in tank. Add adjuvants, fertilizers, and pesticides if desired and agitate until thoroughly mixed. Add recommended amount of N-BORON and agitate until thoroughly mixed. Fill tank with remainder of water.

**Caution:** Check chemical mixture compatibility using a jar test prior to application.
