**Prelontra™ Rodent Monitoring Soft Block** is a nontoxic, highly palatable soft block for monitoring the activity of rodent infestations as part of an Integrated Pest Management (IPM) program.

Formulated not to contain any of the 9 food allergens (milk, eggs, fish, shellfish, tree nuts, sesame, peanuts, wheat, and soybean)\*. Use *Prelontra* for rodents and nuisance animals in and around, but not limited to: residential, industrial and commercial buildings, agricultural and food facilities, schools and other public buildings, ports, airports, terminal facilities and transportation equipment.

## **Directions For Use**

Determine areas where monitoring bait is likely to be consumed, such as along walls, by gnawed openings, in or beside burrows, in corners and between floors, drop ceilings, or walls. Remove as much alternative food as possible. Each 14g soft block has a central hole for ease of securing and is wrapped in a perforated film that allows the natural odors to escape while providing protection against damage by snails and slugs. Suggested placement is 2-8 sachets for rats/nuisance animals and 1-2 sachets for mice in/around bait stations. on snap traps or glue boards, or in/around live-catch traps. Soft blocks may be skewered on a wire for placement in hard-to-reach places. Certain placements may require bait be removed from the sachet – empty sachets should be discarded in the trash. Inspect bait routinely for rodent activity and dispose of any possible litter in accordance with local requirements.

**Prelontra** non-toxic monitoring soft blocks are packaged in the same polyolefin film sachet and formulated with similar food ingredients as **Selontra® Rodent Bait**. Switching to **Selontra** following signs of rodent activity may lead to the fastest control results, as the rodents will readily recognize the **Selontra** bait as a known food source.

# Storage and Disposal

**Storage:** Store in original container in a cool, dry place inaccessible to children and pets and away from items with an odor that might negatively impact the palatability of the bait. Keep container closed and away from other chemicals.

**Waste Disposal of Substance:** Wastes resulting from the use of this product may be placed in trash or incinerated in accordance with local regulations.

**Container Disposal:** Packaging should be emptied as far as possible and disposed of in the same manner as the substance/product.
