### 3. Composition/information on ingredients

**Methods for cleaning up**

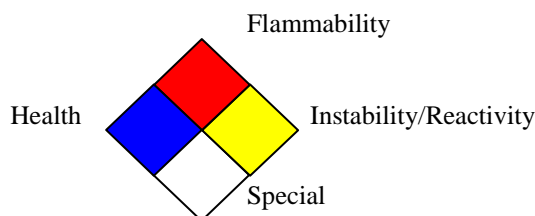
