- Spill** :
- Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. 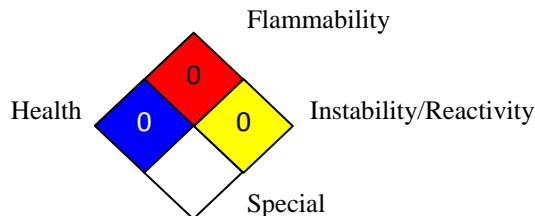
