**HAZARDS TO HUMANS.**

**CAUTION.** Harmful if swallowed. Wash hands thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco, or using the toilet.

**HAZARDS TO DOMESTIC ANIMALS**

For external use on cats only. Do not use on kittens weighing less than 1.5 lbs. and less than 8 weeks of age. **DO NOT USE ON DOGS. DO NOT USE ON OTHER ANIMALS.** Individual sensitivities, while rare, may occur after using **ANY** pesticide product. Cats may experience some temporary irritation at the site of product application. If signs persist, or become more severe within a few days of application, consult a veterinarian. If your cat has an unusual reaction to the initial application, consult a veterinarian before repeating treatment. Certain medications can interact with pesticides. Consult a veterinarian before using on medicated, debilitated or aged cats. Call 1-800-775-9416 for 24-hour assistance.

**SIDE EFFECTS**

Monitor your cat after application. Side effects may include skin irritation such as redness, scratching or other signs of discomfort. In some cases, vomiting or diarrhea may result due to grooming after treatment. If these or other side effects occur, consult your veterinarian or call us at 1-800-775-9416.

To kill fleas, flea eggs and larvae, all stages of **Brown Dog ticks, American dog ticks, Lone Star ticks,** and **Deer ticks** (which may carry Lyme disease), and chewing lice, apply this product to cats and kittens weighing over 1.5 lbs. and 8 weeks or older as follows.

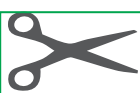

Vetality™ Firstect™ Plus For Cats remains effective even after bathing, water immersion, or exposure to sunlight. Vetality™ Firstect™ Plus For Cats can also be used for the treatment and control of flea, tick, and chewing lice infestations on breeding, pregnant and lactating queens.

Do not allow your cat to ingest this product. Do not apply to cats weighing less than 1.5 lbs. and less than 8 weeks old. Do not use more than one applicator per cat.



HOW TO OPEN:

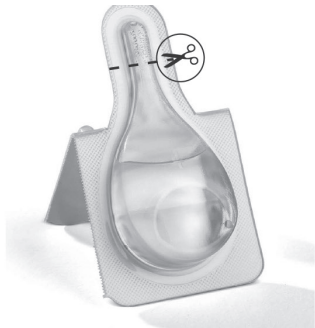
1 Tear through perforation.



2 Fold back the safety tab.



3 Cut with scissors to open applicator.



HOW TO APPLY:

- 1. Prepare applicator as shown in "How to Open".
- 2. Part the hair on the neck at the base of the skull until the skin is visible. Place the tip of the applicator on the skin and squeeze the applicator to apply the entire contents directly on the skin of your cat. Do not allow your cat to ingest this product, or get the product into their eyes. Proper placement of the product on your cat will minimize the opportunity for the cat to lick and ingest the product. Carefully avoid allowing the product to run off the side of the cat.
- 3. Discard empty applicator and packaging as described in the Storage and Disposal section.
- 4. Under normal conditions the product remains effective for a month. In cases of severe flea infestation, retreatment may be necessary earlier than one month. Do not reapply Vetality™ Firstect™ Plus For Cats more often than once every seven (7) days. Once flea control is attained, return to a monthly application schedule.



FREQUENCY OF APPLICATION

**Fleas:** When used monthly, Vetality™ Firstect™ Plus For Cats kills all stages of the flea life cycle and prevents reinfestation of fleas on your cat for up to six weeks after application. Although Vetality™ Firstect™ Plus For Cats can control fleas for up to six weeks, if there is a high risk of re-infestation of fleas on your cat, or if the cat has fleas which may cause flea allergy dermatitis, apply Vetality™ Firstect™ Plus For Cats once every 30 days.

**Ticks:** Vetality™ Firstect™ Plus For Cats kills all stages of the tick life cycle (larvae, nymph, and adult) for at least 30 days. For best control of ticks, apply once every 30 days.

**Chewing Lice:** Vetality™ Firstect™ Plus For Cats kills chewing lice for at least 30 days. For best control of chewing lice, apply once every 30 days.

Do not reapply Vetality™ Firstect™ Plus For Cats for 30 days.

STORAGE AND DISPOSAL

Do not contaminate water, food, or feed by storage and disposal.

**PESTICIDE STORAGE.** Store unused product in original container only, out of reach of children and animals. **PESTICIDE DISPOSAL.
