**For Pet Bedding, Cat Furniture, Collars, Pillows, Blankets, Carpet and Rugs:** This product is designed to be non-staining when used as directed; however, always apply a small amount to an inconspicuous area to test for colorfastness before treating. Spray the surface uniformly with a light mist until moist. Avoid soaking. A fine mist is all that is necessary to be effective. Can be used around cats and dogs 12 weeks or older.

**For Cats 12 Weeks or Older:** Lightly spray pet's entire coat until damp, but not dripping. Do not spray in the face, eyes or genitals. Cover the entire coat including the legs, tail and stomach. Massage into the coat until the product reaches the skin. Repeat as necessary allowing 2-4 hours between applications.

In order to help reduce the occurrence of fleas and ticks, this product is best used year round and when combined with other Vet's Best® products for pet, home and yard.

### PRECAUTIONARY STATEMENTS HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**HUMANS:** Causes moderate eye irritation. Wash hands thoroughly with soap and water after use. Prolonged or frequent repeated skin contact may cause allergic reaction in some individuals. For external use only.
