Dehydrated alfalfa meal, wheat middlings, ground corn, monocalcium phosphate, soybean oil, potassium chloride, dried whey, ferrous sulfate, salt, ground limestone, choline chloride, magnesium sulfate, manganese sulfate, sodium selenite, L-lysine, DL methionine, vitamin A supplement, vitamin D₃ supplement, vitamin E supplement, riboflavin, vitamin B₁₂ supplement, niacinamide, calcium pantothenate, potassium iodide, thiamine mononitrate, pyridoxine hydrochloride, zinc sulfate, copper sulfate, ethylene diamine dihydride, cobalt sulfate, propionic acid (as preservative).

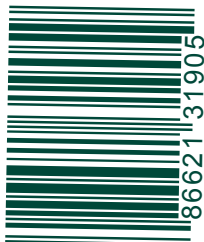
