Carcinogenicity : Etofenprox is not classified as a carcinogen by IARC, NTP, OSHA. Tetramethrin is not listed as a carcinogen by

IARC, NTP or OSHA. Piperonyl butoxide is not classified as a carcinogen by IARC, NTP, OSHA.

Reproductive Effects : Etofenprox did not produce teratogenic or reproductive effects in laboratory experiments. Tetramethrin is not a teratogen. Piperonyl butoxide did not produce any birth defects or adverse effects on reproductive parameters in tests

with rats and rabbits.
