Ecotoxicological Information

Note that the following results are based on tests conducted under laboratory conditions using DPX-MP062 Technical as the test substance. The DPX-MP062 Technical used in the tests contained 94.5% active ingredient in the form of the insecticidally active isomer DPX-KN128 and inactive isomer IN-KN127 in an approximately 75:25 ratio.

(94.5% DPX-MP062)

AQUATIC TOXICITY:

- 96 hour LC50 Bluegill sunfish: 0.90 mg/L.
- 96 hour LC50 Rainbow trout : 0.65 mg/L. 48 hour EC50 Daphnia magna : 0.60 mg/L.

Based on the above results for fish and invertebrates, risk quotients (RQs) were < 0.002 and no levels of concern (LOCs) were exceeded.

AVIAN TOXICITY:

Acute Oral LD50 - Bobwhite Quail : 98 mg/kg. Acute Dietary LC50 - Bobwhite Quail: 808 ppm Acute Dietary LC50 - Mallard Duck : >5620 ppm

Based on the above results for birds, acute RQs were < 0.03 and chronic RQs were < 0.1, and no LOCs were exceeded.
