ABOUT THE ACTIVE INGREDIENT

The active ingredient Spinosad is a mixture of two naturally occurring substances known as spinosyn A and spinosyn D. Found in soil, Spinosad affects the nervous system of insects and is utilized in over 80 registered products. Insects that either eat or come into contact with the active ingredient will experience uncontrolled muscle flexing which will lead to paralysis and death.

Kills the colony and queen (excluding fire ants, carpenter ants, harvester ants and pharaoh ants). Registered for use in residential, lawns and ornamental, industrial, recreational settings. People and pets may enter area when tamper and spill proof bait stations are in use.
