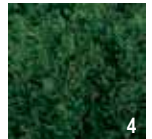

Spot Magic grass seed mix has been tested using the U.S. Department of Agriculture purity standards and regulations. Our certified test results are shown on the package seed label. Weed seed is shown as a percentage of the total weight. Imitation mixes that contain as little as 1/10 of one percent weed seed can result in hundreds of unsightly weeds in your lawn. Spot Magic uses only the highest quality grass seed mixture for maximum results. Don't settle for an imitation - trust your lawn to Spot Magic!

**EASY TO USE SPOT MAGIC** is applied in 3 easy steps and can be used anytime during the growing season. Spring and fall are ideal for Spot Magic. Follow the simple easy-to-use directions illustrated below.

**EVERYTHING YOU NEED** to make lawn repairs is in Spot Magic: seed, fertilizer and mulch. Premium grass seed, mulch and fertilizer in combination create the perfect environment for germination. Fertilizer helps speed root development by 2-3 times, ensuring lasting growth. Spot Magic provides crucial elements for successful lawn repair.

**IMPORTANT: WATER IMMEDIATELY THEN AS NEEDED TO KEEP MOIST** until new growth blends with existing lawn. Best results are attained by using a fine spray. Do not use weed killer in the repair area for several weeks before applying Spot Magic, or while new growth is being established.

**Shake container vigorously before using to evenly distribute the ingredients.**



(1) **Rake Bare Area** removing weeds and debris. (2) **Apply Spot Magic right from the container.** Spread evenly to a depth of about 1/8 inch. (3) **Water Immediately** then as needed to keep moist until new growth blends with existing lawn. (4) **New Growth Will Appear in 7-10 Days** under normal conditions.

**GUARANTEE:** If you are not completely satisfied with Spot Magic within 60 days of purchase, simply cut the seed label from the container and return it with the cash register receipt to Bonide Products, Inc. for a full refund of your purchase price. (Note. The seed label is located on the side of the container and identifies the product, lot number, seed content, and fertilizer analysis.)

**CAUTION:** Keep out of the reach of children. Not for internal consumption. May be harmful if ingested. Eye contact with contents may cause irritation. Flush eyes with water as soon as possible. To prevent staining avoid contact with clothing and wash hands thoroughly after handling. For those with allergies, dust from mulch may cause an allergic reaction. Store in original container, in a cool dry place out of reach of children and pets.

A copy of the complaint shall be sent to the seller by certified or registered mail or as otherwise provided by state statute.
