DIRECTIONS FOR USE

It is a violation of Federal law to use this product in a manner inconsistent with its labeling.

STOP. READ ENTIRE LABEL BEFORE USE. Use Information: SHAKE WELL BEFORE EACH USE. To ensure optimum performance hold upright at all times while spraying. Failure to do so can result in loss of propellant. Do not spray up into air. Apply to surfaces only. Direct spray away from face. Hold can 12-18 inches from surface being sprayed. Press button down and spray as directed.

This product's long-lasting action keeps on killing **Carpenter Ants** for up to 30 days, **American & German Cockroaches** and **Argentine Ants** for up to 18 months on non-porous surfaces. More frequent applications may be necessary on concrete surfaces after you spray. Check these areas in 4 weeks and re-treat if insect activity continues. Residual activity kills insects when they return to treated areas. This formulation is non-staining on surfaces where water alone does not stain. However, when treating delicate fabrics or high value items, first test an inconspicuous area and allow to dry.

This product is intended to be used in and around residences and their immediate surroundings including: apartments, attics, basements, bathrooms, carports, clothes storage, condominiums, decks, dens, driveways, garages, gazebos, homes, kitchens, living rooms, parlors, patios, pet sleeping areas, play rooms, porches, rooms, solariums, storage areas, sun rooms, utility rooms and verandas. Do not use in commercial food/feed handling establishments, restaurants or other places where food/feed is commercially prepared, processed or stored.

INDOORS:

Cockroaches (including Adult and Immature Stages of Both Non-Resistant and Organophosphate and Carbamate Resistant Strains), Ants (including Argentine, Carpenter, Fire, Harvester & Pharaoh), Boxelder Bugs, Centipedes, Crickets, Dermestids, Firebrats, Fleas, Palmetto Bugs, Silverfish, Sowbugs, Ticks and Waterbugs. Apply as a spot and crack and crevice treatment to areas where these pests crawl and hide, especially in hidden areas around sinks and storage areas, behind baseboards, around doors and windows, behind and under refrigerators, cabinets, sinks and stoves, the underside of shelves, drawers, bookcases, and similar areas. Cover all food handling surfaces and cover or remove all food and cooking utensils or wash thoroughly after treatment. Cover or remove exposed food. Repeat as necessary but not more than once per week.

Ants: Spray ant trails and around doors and windows and other places where ants enter the house. Repeat as necessary but not more than once per week.
Carpenter Ants: For effective control, locate and treat nests and surrounding areas. Apply around doors and windows and other places where ants enter premises and where they crawl and hide. Spray into infested wood through existing openings.

Ticks and Fleas ON SURFACES: Remove pet bedding and destroy or clean thoroughly. Spray pet resting quarters.

Adult Fleas and Larvae contacted by spray will be killed. Put fresh bedding down once spray has dried. **DO NOT SPRAY ANIMALS DIRECTLY.** For best results, treat pets with an appropriate flea and/or tick control product registered for use on pets before allowing them to return to the treated area. Spray rugs and carpets where infestations are bad. Test delicate fabrics for staining in an inconspicuous area prior to use.

Spiders: Apply along and behind baseboards, to window and door frames, corners, pipes, storage localities, attics, crawl spaces and other areas over which these pests may crawl.

Centipedes, Ground Beetles, Pillbugs, Sowbugs and Ticks: Apply around doors and windows and other places where these pests may enter premises. Treat baseboards, storage areas and other locations where these pests are found.

Asian Lady Bird Beetles (Lady Bugs): Spray areas where bugs crawl or are rest, around doors, windows and areas where insects can enter the home.

Contact Spray: To kill ants (including Argentine, carpenter, fire, harvester & Pharaoh ants), bed bugs, centipedes, cockroaches, fleas, spiders (including brown recluse, black widow & hobo spiders), ticks, chiggers, black flies, deer flies, horse flies, gnats, biting midges and wasps. Spray where insects congregate and individual pests when seen. Spray 1-2 seconds contacting insects directly. Insects contacted by spray will be killed.

OUTDOORS:

Remove all exposed food and cooking utensils. Cover all food handling surfaces or wash thoroughly after treatment and before use. Do not use on edible crops. Application is prohibited directly into sewer drains, or to any area like a gutter where drainage to sewers, storm drains, water bodies, or aquatic habitat can occur. Do not allow the product to enter any drain during or after application. Do not water the treated area to the point of runoff. Do not make applications during rain. All outdoor application must be limited to spot or crack-and-crevice treatments only, except for the following permitted uses:

1. Treatment to soil or vegetation around structures;
2. Applications to lawns, turf, and other vegetation;
3. Applications to building foundations, up to a maximum height of 3 feet.

Other than applications to building foundations, all outdoor applications to impervious surfaces such as sidewalks, driveways, patios, porches and structural surfaces (such as windows, doors and eaves) are limited to spot and crack-and-crevice applications, only. For outdoor use only as an aid in controlling these insects. Point away from face. Hold on a slight downward angle, approximately 18 inches from surface to be sprayed. Spray with wind if breeze is blowing. Do not contaminate fish ponds or apply directly to water.

PESTS ON OUTSIDE SURFACES OF BUILDINGS: For control of building infestation of Ants, Clover Mites, Crickets and Sowbugs. Spray foundation of building where insects are active and may find entrance up to a height of 2 to 3 feet. Apply to outside surfaces of buildings where insects tend to congregate. Spray areas include (but are not limited to) screens, window frames, eaves, porches, patios, garages and refuse dumps. Repeat treatment as necessary, but not more than once per week.

FLYING INSECTS: House Flies, Gnats, Mosquitoes and small Flying Moths: Spray outside surfaces of window and door frames and other areas where these pests may enter the home. Also spray localized resting areas, such as under eaves, porches, surfaces around light fixtures and cords, railings, etc. where these insects may rest. Insects continue to rest on treated surfaces will be killed.

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry area away from children. Protect from freezing. If freezing occurs, allow product to thaw and shake well before use. Freezing does not adversely affect performance. **PESTICIDE DISPOSAL AND CONTAINER HANDLING:** Do Not Puncture or Incinerate! IF EMPTY: Place in trash or offer for recycling if available. IF PARTLY FILLED: Call your local solid waste agency for disposal instructions.

CAUTION: Contact with product may result in transient tingling and reddening of the skin. Avoid contact with skin or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet.

ENVIRONMENTAL HAZARDS This product is extremely toxic to fish and aquatic invertebrates. Do not apply directly to water. This product is highly toxic to bees and other pollinating insects exposed to direct treatment or residues on blooming crops or weeds. Do not apply this product or allow it to drift to blooming crops or weeds if bees or other pollinating insects are foraging in the treatment area.

PHYSICAL OR CHEMICAL HAZARDS Contents under pressure. Keep away from heat, sparks and open flame. Do not puncture or incinerate container. Exposure to temperatures above 130°F may cause bursting. Do not spray this product in or on electrical equipment due to the possibility of shock hazard.
