

## PRECAUTIONARY STATEMENTS

### HAZARDS TO HUMANS AND DOMESTIC ANIMALS

**CAUTION:** For use on animals only. Not for use on humans. Harmful if swallowed. Causes moderate eye irritation. Avoid contact with skin, eyes or clothing. Wash thoroughly with soap and water after handling and before eating, drinking, chewing gum, using tobacco or using the toilet. Remove contaminated clothing and wash clothing before reuse.

### FIRST AID

Have the product container or label with you when calling a poison control center or doctor, or going for treatment. For additional information (including health concerns, medical emergencies or pesticide incidents), you may call 1-800-222-1222, twenty-four (24) hours per day, seven (7) days per week.

### IF SWALLOWED:

- Call a poison control center or doctor immediately for treatment advice.
- Have person sip a glass of water if able to swallow.
- Do not induce vomiting unless told to do so by a poison control center or doctor.
- Do not give anything by mouth to an unconscious person.

### IF IN EYES:

- Hold eye open and rinse slowly and gently with water for 15-20 minutes.
- Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye.
- Call a poison control center or doctor for treatment advice.

### IF ON SKIN OR CLOTHING:

- Take off contaminated clothing.
- Rinse skin immediately with plenty of water for 15-20 minutes.
- Call a poison control center or doctor for treatment advice.

### ENVIRONMENTAL HAZARDS

This product is extremely toxic to fish. To protect the environment, do not allow pesticide to enter or run off into storm drains, drainage ditches, gutters or surface waters. Applying this product in calm weather when rain is not predicted for the next 24 hours will help to ensure that wind or rain does not blow or wash pesticide off the treatment area.

### DIRECTIONS FOR USE

#### RESTRICTIONS:

- Apply only as specified on this label. • Except when applying directly to animals, do not allow adults, children or pets to enter the treated area until sprays have dried. • Except when applying directly to animals, do not apply this product in a confined space. • Do not use in areas where animals are housed. • Do not use on or cover exposed food and drinking water before application. • Remove or cover dishes, utensils, food processing equipment and food preparation surfaces or wash them before use. • Application is prohibited directly into sewers or drains or any area like a gutter where drainage to sewers, storm drains, water bodies or aquatic habitat can occur. Do not allow the product to enter any drain during or after application. • Not for use in outdoor residential misting systems.

#### FOR USE ON HORSES. USE FULL STRENGTH:

This non-oly insecticide/repellent may be applied with a spray application or as a wipe.

#### DIRECTIONS FOR WIPE-ON USE:

Thoroughly brush horse to remove excess dirt and dust. Extremely dirty horses should be shampooed, rinsed and allowed to dry before applying wipe. Use a sponge or clean soft cloth or mitt. Apply liberally (1/2 ounce) over areas to be treated. Avoid eyes and mucous membranes. Reapply in 10-14 days or as needed to maintain control. Reapply after animal is washed, has had excessive sweating or if exposed to heavy rain.

#### DIRECTIONS FOR SPRAY USE:

Remove excess dirt and dust. Apply 1-2 ounces as a light spray mist to coat while brushing lightly against lay of the hair. Avoid spray in eyes and mucous membranes. Apply with sponge or soft cloth to these areas. Reapply in 10-14 days or as needed to maintain control. Reapply after animal is washed, has had excessive sweating or if exposed to heavy rain.

#### STORAGE & DISPOSAL

Do not contaminate water, food or feed by storage or disposal.  
**Storage:** Store in a cool, dry place.  
**Disposal:** If empty: Non-refillable container. Do not reuse or refill this container. If partly filled: Call your local solid waste agency for disposal instructions. Never place unused product down any indoor or outdoor drain.

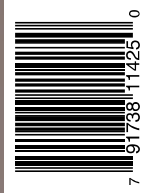
