4. FIRST AID MEASURES

If Swallowed: Call a poison control center or doctor immediately for treatment advice. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by the poison control center or doctor. Do not give anything by mouth to an unconscious person.

Most Important symptoms/effects, acute and delayed: None expected.

Indication of Immediate medical attention and special treatment if needed: For ingestion there is no specific antidote available. Treat symptomatically.

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES

Personal Precautions: Wear appropriate protective gear for the situation. See Personal Protection information in Section 8.

Environmental Precautions: Prevent material from entering public sewer systems or any waterways. Do not flush to drain. Large spills to soil or similar surfaces may necessitate removal of topsoil. The affected area should be removed and placed in an appropriate container for disposal.

Methods for Containment: Dike spill using absorbent or impervious materials such as earth, sand or clay. Collect and contain contaminated absorbent and dike material for disposal.

Methods for Cleanup and Disposal: Avoid creation of dusty conditions. If dry, sweep or scoop up material and place into container for disposal. If wet, pump any free liquid into an appropriate closed container. Decontaminate tools and equipment following cleanup. See Section 13: DISPOSAL CONSIDERATIONS for more information.

7. HANDLING AND STORAGE

HANDLING:

Harmful if absorbed through skin. Harmful if inhaled. Avoid contact with skin, eyes, or clothing. Users should wash hands before eating, drinking, chewing gum, using tobacco or using the toilet. Remove clothing immediately if pesticide gets inside. Then wash thoroughly and put on clean clothing. Remove Personal Protective Equipment (PPE) immediately after handling this product. Wash the outside of gloves before removing. As soon as possible, wash thoroughly and change into clean clothing.

STORAGE:

Store in a cool, dry place and in such a manner as to prevent cross-contamination with other pesticides, fertilizers, food and feed. Store in original container and out of the reach of children, preferably in a locked storage area. Do not contaminate water, food, or feed by storage or disposal.

8. EXPOSURE CONTROLS / PERSONAL PROTECTION

Engineering Controls:

Where engineering controls are indicated by specific use conditions or a potential for excessive exposure, use local exhaust ventilation at the point of generation.

Eye/Face Protection: To avoid contact with eyes, wear chemical goggles or shielded safety glasses. An emergency eyewash or water supply should be readily accessible to the work area.

Skin Protection: To avoid contact with skin wear long pants, long-sleeved shirt, socks, shoes and chemical-resistant gloves. An emergency shower or water supply should be readily accessible to the work area.

11. TOXICOLOGICAL INFORMATION

Likely Routes of Exposure: Skin contact, Inhalation, Eye contact

Symptoms of Exposure: None expected.

Skin Sensitization: Not a contact sensitizer in guinea pigs following repeated skin exposure.

Subchronic (Target Organ) Effects: Repeated overexposure to imidacloprid may affect heart, thyroid, blood chemistry, and liver.

Carcinogenicity / Chronic Health Effects: Prolonged overexposure to imidacloprid can cause effects to the thyroid. Imidacloprid did not cause cancer in laboratory animal studies. The U.S. EPA has given imidacloprid a Group E classification (evidence of non-carcinogenicity in humans).

Reproductive Toxicity: In a two-generation reproduction study in rats, imidacloprid produced reduced mean body weights and body weight gains. No other reproductive effects were observed.

Developmental Toxicity: Rat and rabbit studies on imidacloprid resulted in skeletal abnormalities, increased resorptions (rabbits) and reduced body weight gains at doses that were also toxic to mother animals.

Genotoxicity: The imidacloprid mutagenicity studies, taken collectively, demonstrate that imidacloprid is not genotoxic or mutagenic.

Assessment Carcinogenicity: None listed with ACGIH, IARC, NTP or OSHA.

Environmental Fate:

Hydrolysis half-life of imidacloprid is greater than 30 days at pH 7 and 25°C. The aqueous photolysis half-life is less than 3 hours. The soil surface photolysis of imidacloprid has a half-life of 39 days, and in soil, the half-life ranged from 26 to 229 days.

13. DISPOSAL CONSIDERATIONS

Waste Disposal Method:

Wastes resulting from the use of this product may be disposed of on site or at an approved waste disposal facility.

Container Handling and Disposal:

Nonrefillable Containers 5 Gallons or Less:

Nonrefillable container. Do not reuse or refill this container. Triple rinse container (or equivalent) promptly after emptying. **Triple rinse as follows:** Empty the remaining contents into application equipment or a mix tank. Fill the container 1/4 full with water and recap. Shake for 10 seconds. Pour rinsate into application equipment or a mix tank or store rinsate for later use or disposal. Drain for 10 seconds after the flow begins to drip. Repeat this procedure two more times. Then offer for recycling or reconditioning, or puncture and dispose of in a sanitary landfill, or by other procedures approved by State and local authorities. Plastic containers are also disposable by incineration. Do not burn unless allowed by state and local ordinance If burned stay out of smoke.

Refillable containers larger than 5 gallons: Refillable container. Refill this container with pesticide only. Do not reuse this container for any other purpose.
